Mind Power University, Bhimtal (Nainital)

- 11. **"End Term Examination**" means an examination conducted by the Mind Power University at the end of year/semester as prescribed in Scheme of Evaluation of a programme.
- 12. "Mid Term Examination" means an examination conducted by the Mind Power University at the mid of year/semester as prescribed in Scheme of Evaluation of a programme.
- 13. **"Examination Centre"** means any Faculty, or part thereof, fixed by the University for the purpose of holding its examinations and includes the entire premises attached thereto.
- 14. **"Examination Committee**" means the Committee constituted by the Academic Council in accordance with the Ordinance of University Act to devise detailed procedure for an efficient, transparent and fair evaluation of students, including coordination of activities relating to conduct of examinations.
- 15. **"Unfair Means Committee (UMC)**" shall mean the Committee constituted by the Vice Chancellor at the University to consider and decide the cases relating to the acts of misconduct, misbehavior, indiscipline and/or use of unfair means by the students in the examinations.
- 16. **"External Examiner**" shall mean a person who is not in the employment of the Mind Power University, Bhimtal (Nainital) or its Constituent Units and is appointed as an Examiner.
- 17. "Letter Grade and Grade Points" shall mean Letter Grades and Grade Points of a course as prescribed in these ordinances.
- 18. "IA" (Internal Assessment) shall mean Continuous Internal Assessment of a course during the semester.
- 19. **"Internal Examiner**" shall mean an Examiner for practical, viva-voce, workshop practice, seminars etc. including a paper setter and evaluator who is a teacher of the University and its Constituent Units.

"Room Superintendent" means a person who assists the Superintendent of the Examination Centre in conducting and supervising an examination at a center.

"Maximum Duration for Programme" shall mean the maximum period specified in the Scheme of Teaching and Evaluation for a degree, diploma and certificate programme for in which a candidate may is allowed to complete the programme.

22. "Minimum Duration of Programme" shall mean the minimum period

specified in the Scheme of Teaching and Evaluation of a degree, diploma and certificate programme in which a candidate is allowed to complete the programme.

- 23. **"PG Diploma"** shall mean the Post Graduate Diploma in areas approved by the Academic Council and Board of Management of MPU.
- 24. "Question Paper" means a document containing the question(s) to be administered at an examination to be answered by a candidate
- 25. "Results Moderation Committee" shall mean the Committee appointed by the University to moderate grades/ marks awarded by the Evaluators in different course units at a given level of a curriculum.
- 26. "Scheme of Teaching and Examination" shall mean the scheme of teaching and examination for a programme as approved by the Academic Council.
- 27. **"Faculty**" means different schools established under the Mind Power University.
- 28. "Semester System" means teaching/learning/evaluation of student performance in an academic programme of the University and its Constituent Units twice in an Academic Year.
- 29. "Centre Superintendent of an Examination Centre" means a person appointed by the University to conduct and supervise its examinations held or to be held at a center, and includes an Additional Superintendent or Deputy Centre Superintendent of such center.
- 30. **"Tabulator**" means a person, specially engaged for tabulating the result from award lists and the result sheets prepared by the Office.
- 31. "**Teaching Experience**" denotes teaching experience in the subject in an institution recognized by the University
- 32. "Year" means the academic year.
 - (a) "AB" (Academic Break) shall mean students not promoted to Next Year due to personal reasons/weak academic record.
 - (b) "YB" (Year Back) shall mean student brought to lower batch due to poor academic performance.

O-1: Short Title

- (i) These ordinances shall be called the Ordinances of University Examinations of the Mind Power University, Bhimtal (Nainital).
- (ii) These ordinances shall come into force with effect from the date of adoption by the Board of Management.
